PROGRAM GUIDELINES

You must complete 64 units, comprising -

- 28 units for all BAdvBus(Hons) Core Courses; and
- 16 units for one major from BAdvBus(Hons) Majors; and
- 4 units of general electives; and
- either -
 - 16 units for a second major from BAdvBus(Hons) Majors; or
 - 16 units from the BAdvBus(Hons) Research Pathway Option.

Selected courses must include at least 24 units at level 3 or higher.

Note:

Students will be required to complete the first 40 units of the program with a cumulative GPA of at least 5.5 to be eligible for the Research Pathway Option.
