Work-integrated Learning (WIL) allows BEL students in their final year of study to put classroom theory into practice by undertaking a consultancy project, individual internship or intensive project placement for course credit. A WIL internship can be either paid or unpaid, and is also best advertised on UQ CareerHub.

# 🖧 Unpaid Work Experience

Work experience is an opportunity for students to gain important industry experience outside of their assessable course curriculum. In Queensland, work experience is regulated by the *Education (Work Experience) Act 1996 (Qld).* Please see below for more information.

# Advertising your opportunity

You can advertise a paid job (including paid vacation and internship programs), volunteering or Work-integrated Learning opportunities on **UQ CareerHub**. Please refer to this **guide** for instructions on how to create an account and post an opportunity on the platform.

#### Advertising unpaid work experience

In accordance with the UQ CareerHub **Terms and Conditions**, for an unpaid opportunity to be approved for advertisement, it needs to:

- be offered as a **volunteering opportunity** by an organisation registered with the Australian Charities and Not-for-profits Commission (ACNC);
- be a component of a formal academic program or **Work-integrated Learning** activity with a clear statement of relevant learning outcomes; or
- be part of a UQ-approved work experience program.

In the BEL faculty, students in their final year may enrol in a Work-integrated Learning course to develop their practical workplace skills and enhance their employability. Students may complete a consultancy project, individual internship or intensive project placement as part of a WIL course.

BEL students in any year of study may also participate in the **Student Work Experience Program (SWEP)**. This extra-curricular program engages students during the semester in a structured mock recruitment process based on current industry practices and facilitates paid or unpaid work experience placements for eligible students during the following semester break. SWEP host organisations provide students with meaningful pre-professional learning experiences to help build their employability and awareness of potential career pathways. # Insurance and approval process for unpaid work experience

Under the *Education (Work Experience) Act* 1996 (Qld), UQ can approve unpaid work experience placements for a student if:

- the work experience is of limited duration (maximum of 30 days per year);
- it will finish in the year it has started;
- it will be completed during the ordinary working hours of the business;
- it is relevant to the student's education; and
- the number of students on placement does not exceed the number of full-time employees of the placement organisation.\*

Prior to hosting a student for work experience, the student and employer must complete the **Unpaid Work Experience Registration Form**. On the form, details of the work activities to be undertaken by the student and the student's learning objectives for the placement must be specified. The signed form then needs to be sent to **careers@bel.uq.edu.au** for approval before the placement commences.

Once the unpaid work experience has been approved, the student will be covered by UQ insurance for the duration of the activity. If there are any changes to the arrangement, they need to be communicated to BEL Careers and Employability to maintain compliance with the law and UQ's policy governing Work-integrated Learning and work experience.
