PROGRAM GUIDELINES

You must complete 48 units*, comprising -

- 16 units for all BBusMan Core Courses; and
- 16 units for one major from BBusMan Majors; and
- 16 units for either:
 - o 16 units for a second major from BBusMan Majors; or
 - 16 units of General Elective Courses**

Note:

*At least 8 units (4 courses) must be at level 3 and no more than 24 units (12 courses) may be at level 1 (therefore excluding BBusMan Core Courses, maximum 8 units may be level 1 courses).

**General Electives can come from the BBusMan course list, or other undergraduate course lists at UQ providing you have met the prerequisites; they are not incompatible with any of the courses in your program, nor a prerequisite to your program (e.g. you cannot gain credit for MATH1040 if you studied Mathematical Methods in high school and used it to meet the maths prerequisite for the program).
