## NOTES

### ❖ Grades of 3

Only #8 at a pre-2006 grade of 3 (conceded pass) can be counted towards the dual degree (#8 across both components – NOT #8 each).

From Semester 2 2004, any grade of 3 obtained in a previous program cannot be granted as credit towards any new program.

### ❖ MATHS B/ MATH1040 - Pre-2008 Students

Students who entered the program prior to 2008 without having completed Maths B at secondary school or the equivalent at tertiary studies, must complete MATH1040 as a General Elective. From 2008, all students are required to have completed Maths B or equivalent for entry to the program.

The only exception is for domestic Qld Year 12 School leavers of 2007 (or 2006 who officially deferred commencement) who entered the program in 2008 without having completed Maths B at secondary school must also complete MATH1040 as a General Elective.

**If you have completed Maths B or an equivalent, you are not permitted to take MATH1040**, regardless of when you commenced the program.

### ❖ Incompatibles

**\*ECON1050 is incompatible with** EC131 or MATH1050 or MATH1051.

**\*\*ECON1310 is incompatible with** EC134 or EC135 or CHEE3010 or MINE3214 or STAT1201 or 2201 or (MS101+(102 or 112) or 103 or 113 or 240).

Where students have taken an incompatible course to ECON1050 and/or ECON1310, they may be eligible for credit or an exemption will apply.

Students who are exempt from ECON1050 and/or ECON1310 are required to take a #2 BEcon course in replacement of each #2 exemption.

If you completed ECON1050 + MATH1050 prior to 2013, or you completed ECON1050 + MATH1051 in 2013, please contact an Academic Administrative Officer in the BEL Faculty for advice.

Students who completed PSYC1040+PSYC2010 prior to 2012 should contact an Academic Administrative Officer in the BEL Faculty for advice regarding ECON1310.

### ❖ LLB courses (only applicable to previous dual BBusMan/LLB or BEcon/LLB students who program change to a BBusMan/BEcon dual program)

LAWS1000+LAWS1001 = LAWS1100  
(LAWS1113+LAWS2111 = LAWS1100)

An additional #2 level 1 general elective may be given as credit subject to special circumstances and approval from the Associate Dean (Academic).

### ❖ Pre-2011 Students

Pre-2011 students must obtain permission from the Faculty of Business, Economics and Law IF they wish to change to the 2011 rules. Otherwise they MUST follow the program rules and course list for the year in which they commenced their program.

### ❖ FINM2400/2401

From 2014, FINM2400 will replace FINM2401 in the BBusMan Group 1 Compulsory Course List.

If you have already successfully completed FINM2401, this course will continue to be counted towards your compulsory group 1 courses. If you have not completed FINM2401, you have the option of taking FINM2401 towards your compulsory group 1 courses or replacing it with FINM2400.
