#### **PROGRAM GUIDELINES**

You must complete 64 units, comprising -

- 28 units for all BAdvBus(Hons) Core Courses; and
- 16 units for one major from BAdvBus(Hons) Majors; and
- · 4 units of general electives; and
- either
  - o 16 units for a second major from BAdvBus(Hons) Majors; or
  - 16 units from the BAdvBus(Hons) Research Pathway Option.

Selected courses must include at least 24 units at level 3 or higher.

#### Note:

To be eligible for entry to the Research Pathway Option, a student must have a cumulative GPA of at least 5.5 for the program and have completed at least 40 units in the program.
