What does a course look like?

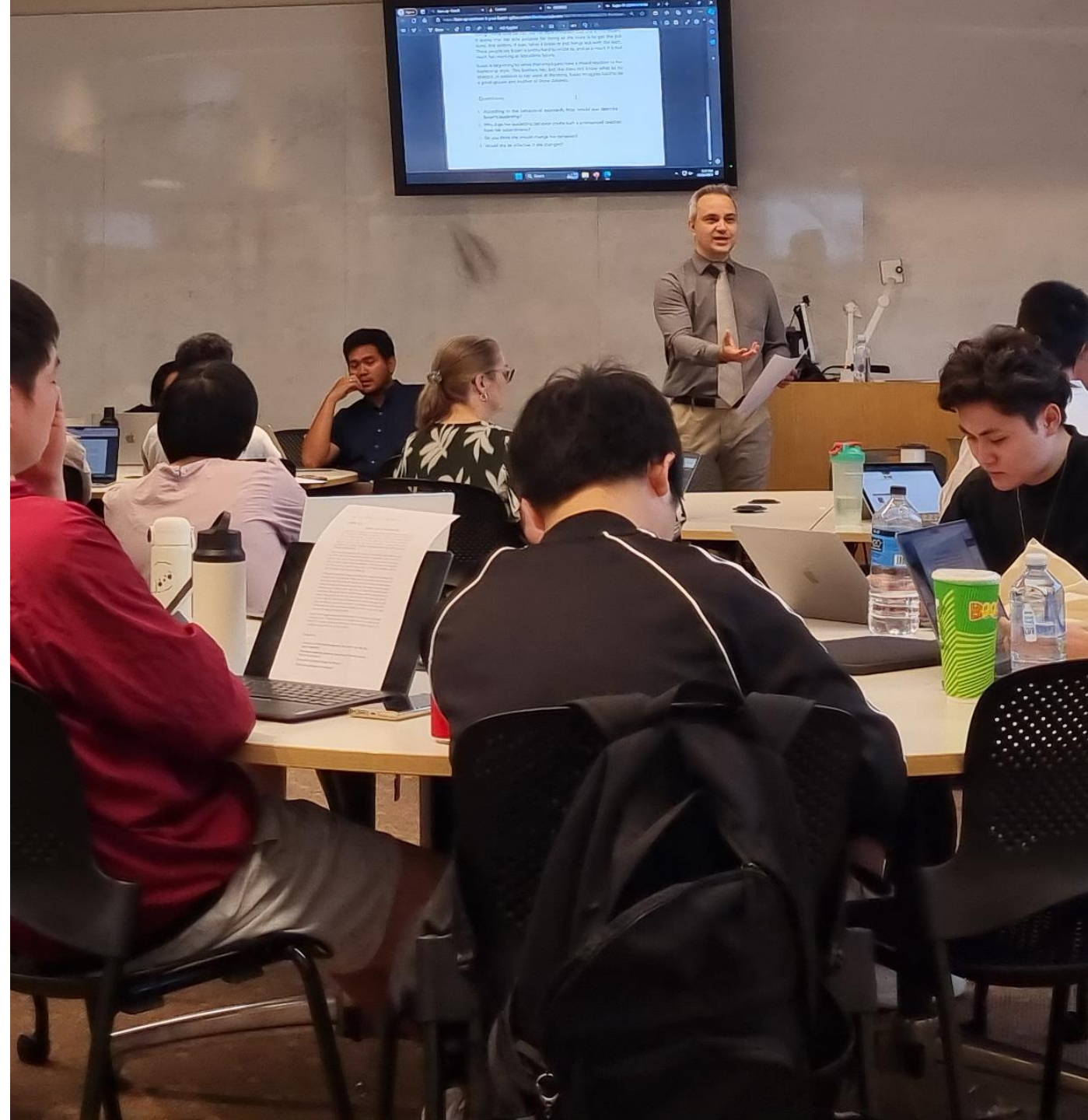
At UQ, we call subjects 'courses'.

- how you are going to be **assessed**.

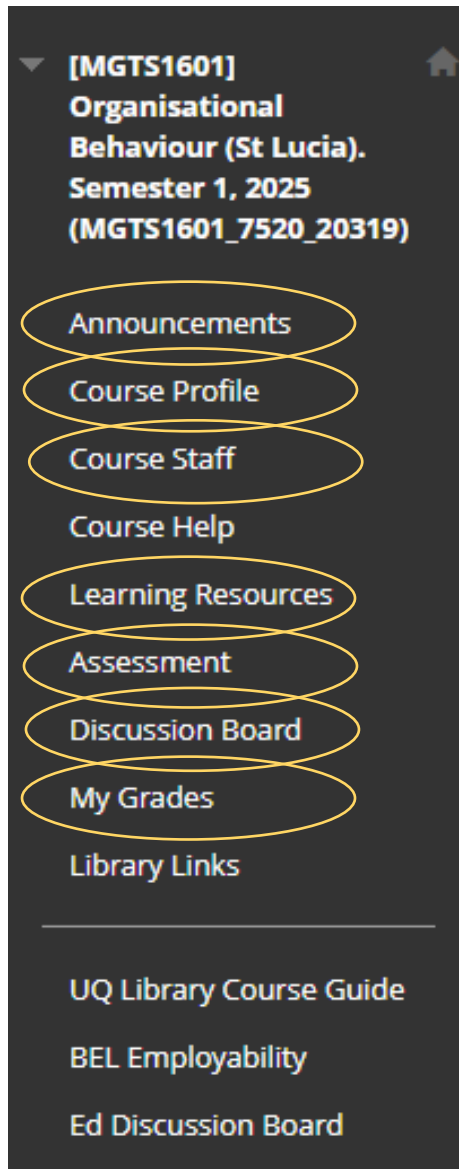

What do you have to do?

Each course, learning activities and assessments are designed to meet the UQ expectations that each student is expected to engage in **10 hours per week for each course.**

Make sure to go into each course blackboard and get comfortable with the system.



What is class time for?

It is up to you to **prepare for class**, complete any online modules or reading required to participate, schedule time to complete assessments, and work with others in your class.

Class time is a time where you can think about the knowledge being introduced that week. It is time for you to **ask questions**, gain an understanding of the course content, clear any doubts and get some experience in using the knowledge.

It is also a great time to ask questions that you have about your assessments.

Knowledge and experience don't just happen – **you must be an active learner.**

How will you be assessed?

It depends on each course as to the best way to assess your learning. Be sure to check the CP for details of when and how you will be assessed.
