## PROGRAM GUIDELINES

You must complete a total of 48\* units from the BBusMan course list comprising -

- 16 units for all BBusMan Core Courses; and
- 16 units for one major from BBusMan Majors and
- 16 units from either:
  - a second major from BBusMan Majors; or
  - General Elective Courses

\*At least 8 units (4 courses) must be at level 3 and no more than 24 units (12 courses) may be at level 1 (therefore excluding BBusMan Core Courses, maximum 8 units may be level 1 courses).

**General Electives** can come from almost any other undergraduate program at UQ providing you have met the prerequisites; they are not incompatible with any of the courses in your program, nor a prerequisite for entry to your program (e.g. you cannot gain credit for MATH1040 if you studied Mathematical Methods or Mathematics B in high school and used it to meet the maths prerequisite for entry into the program).
