

You will gain knowledge and skills in areas such as people management, Australian and international industrial relations, selection and recruitment, organisational change, interpersonal communication, conflict resolution, training and development, negotiating employment agreements, and leadership.





#### **Economics and Public Policy**

In this multidisciplinary major, you will learn how governments develop public policy and how government intervention can influence economies in an increasingly globalised world. You will be taught the tools, concepts and techniques to provide advice on policy development (such as taxation, education, health and transport), as well as to evaluate existing policies. Core courses in public finance and regulatory economics emphasise the theoretical framework and rationale for government intervention. Elective courses include advanced microeconomics, macroeconomics and political sciences.

#### **International Trade and Finance**

International trade and finance are key factors affecting the Australian and world economies. This major focuses on the economics of financial systems, mechanisms and emerging issues in today's globalised economy. You will develop an understanding of the complex nature of economics in the international environment and its close relationship with financial

management institutions. You will also gain the analytical skills for informing managerial and policy responses across business and government on international trade and finance issues

Careers: Graduates enjoy careers in financial institutions, government agencies, consulting firms, and Australian and international private enterprises.

#### **Natural Resources and Environment**

Today, the economic and ecological value of our diverse natural resources is recognised at the international, national and local levels. The effective use of these resources is an important social and political issue. This major will give you the economic analytical tools needed to solve key environmental problems, including the management of renewable and non-renewable natural resources (e.g. river systems, agricultural land, energy and minerals). You will understand and be equipped to deal with the challenges facing business, government and the wider community.

Careers: Graduates enjoy careers in public policy, environmentally focused agencies, private enterprise, mining and energy companies.

#### **Quantitative Methods**

In this major you will learn how to provide rigorous, evidence-based economic analysis that is verifiable and objective. It has a strong mathematical focus, covering measurement, analysis, projection and modelling for a diverse set of economic factors and scenarios. This area of economics is developing quickly and is becoming increasingly sought after by employers as it can provide real, datainformed answers to difficult questions, allowing for better decision-making by governments and businesses. You can select courses in the areas of econometrics, advanced mathematical economics, business and economic decision techniques, and experimental economics.

Careers: Graduates enjoy careers in highlevel finance and investment, research consultancies, management organisations, private business and governmentorientated enterprises.

The Centre's Pro Bono Roster provides links to volunteer opportunities within the legal fraternity and community organisations, where you can support pro bono and public interest work.

#### The Manning St Project

The Manning St Project allows you to pursue an interest in policy, advocacy and law reform, public interest research or community legal education. You will work under the supervision of practising lawyers and academics at Caxton Legal Centre in South Brisbane.

#### **High Schools Program**

You can be involved in one of the outreach community legal education programs offered by the UQ Pro Bono Centre:

- Asylum and Refugee Law
- Domestic Violence and the Law
- International Humanitarian Law (run in conjunction with the Australian Red Cross).

You will liaise with and deliver lesson plans on these areas of law to high school students in the greater Brisbane area.

#### **Co-curricular Education Program**

In partnership with the UQ Law Alumni Association, the co-curricular education program complements core areas of study to give you a real-world understanding of how the concepts you are studying manifest in legal practice.

All first-year students have the opportunity to participate in an immersion day at the Supreme Court that includes a guided tour, observation of a trial and presentations by eminent legal professionals.



#### Internships and work experience

You will have opportunities to gain valuable work experience by undertaking an internship. Prospective employers value work experience and interning is a great way for you to develop your skills and enhance your CV.

#### The Barristers Work Experience Program

An initiative of the Bar Association of Queensland and The University of Queensland Law Society, this is an immersive work experience placement with a participating barrister. You will undertake legal research and shadow a barrister to court and meetings. The program aims to develop your legal skills and provide you with first-hand insight into a career at the bar.

#### The Aurora Native Title Internship **Program**

This program places Australian law students with Native Title Representative Bodies (NTRB) and other Indigenous organisations. Typical duties include preparing briefs for counsel and government submissions, legal research, preparing affidavits, and attending court with NTRB staff.

#### The Office of the Director of Public Prosecutions (ODPP) Work Experience **Placement Program**

Aimed at law students with a genuine interest in criminal law, this program will give you exposure to a variety of criminal law matters and will develop your knowledge of the criminal justice system.

#### The Practitioner-in-Residence program

Introduced in 2013, the Practitioner-in-Residence program enables judges and legal practitioners to share their insights and expertise with the law school community. Participants interact with students and staff to reflect on the practice of law, discuss issues relevant to both academia and practice, and link this with research and theory. Visiting practitioners take part in a variety of campus activities such as student mentoring, delivering guest lectures and participating in practice moots.

#### Research and publication

You will be encouraged to engage in in-depth research on contemporary legal issues and be supported in your efforts to have your research published. You will have opportunities to work closely with leading academics across a variety of areas through research-intensive course options and our Summer Scholars Program.

#### **Mooting program**

Mooting competitions are mock legal hearings in which legal or factual arguments are presented in a hypothetical case before a judge, tribunal member or arbitrator.

#### International recognition

The LLB(Hons) fulfils the academic requirements for admission as a legal practitioner throughout Australia. Students from Singapore, Malaysia or India may use the LLB(Hons) to fulfil the academic qualifications required for admission to the legal profession in their home country. Once admitted in Australia, international students may only need to complete limited conversion modules to be eligible for admission in their home country.

#### Why Law at UQ?

Our courses are taught in small group settings and informal learning spaces within the Forgan Smith Building, which has been refurbished specifically for law students. You will have the opportunity to expand your knowledge with your peers and professors in an active learning environment.

This program offers a thorough understanding of the concepts, principles, policies and values of the law, both in Australia and other jurisdictions. It strives to develop outstanding skills in critical, rational and analytical thinking, and will teach you to craft clear and persuasive arguments - skills that will be valuable in whatever career path you choose.

You will graduate with an internationally respected honours qualification, with advanced knowledge and skills that are transferable across a wide range of careers. Your degree will set you apart in a competitive job market while also providing a pathway to future research or learning.

In addition to the courses required for professional admission, the LLB(Hons) offers a range of elective courses and exclusive co-curricular activities through which you can put the knowledge you have acquired in the classroom into practice.

#### Career opportunities

#### **Legal practitioners**

After completing an LLB(Hons) from UQ, you must also satisfy the practical legal training requirements before you can be admitted as a legal practitioner. Examples of career opportunities include:

#### Solicitor

Solicitors (as sole practitioners or in law firms) are usually the first point of contact for members of the public seeking legal advice. Solicitors are also employed by businesses, government, and community and international bodies to provide legal advice, prepare legal documents, develop policy and advise on legal reform issues.



#### **Barrister**

Barristers represent their clients' interests in court proceedings as specialist advocates. Usually they work independently and choose to specialise in particular areas of the law. They also provide oral or written advice on matters within those areas.

#### Industry

In addition to being a prerequisite for legal practice, the analytical and research skills you develop in the LLB(Hons) program will help you secure a career in many other sectors, including:

#### Government

Law graduates work in various sectors of state and federal government. They can work as legal officers within government departments or may be involved in developing or administering government policy. They may also embark on a career in the diplomatic and foreign service.

#### Corporate

Many law graduates work as in-house lawyers for large companies where they undertake work in a wide variety of areas such as corporate governance, insurance, environmental compliance and employment law.

#### Business

Using their law program - often combined with a business management, commerce or economics program - many graduates undertake careers in the business world in areas such as investment banking, insurance, property development and management. Others pursue careers in the consulting or advisory services industry, working to provide solutions to a wide range of clients.

#### • Community support and social development

Graduates can use their law program, combined with any other program, to work for industry associations, lobby and environmental groups, social service groups, 'think tanks', community service organisations, legal aid and community legal centres.

#### Academia

Law graduates are well equipped to pursue careers in academia. Those with a passion for research and teaching can pursue further study and seek positions where they can contribute to legal scholarship while educating the next generation of legal practitioners.



# APPLY FOR A **SCHOLARSHIP**

Make your UQ experience more affordable with the support of a scholarship. You may not think you're eligible for one, but you might be surprised!

#### **Academic**

UQ's Academic Scholarship Program is designed to reward the achievements of outstanding school leavers and to identify, support and develop tomorrow's leaders. If you are a high-achieving student and are completing Year 12 in 2018, or you completed Year 12 in 2017 and are on a gap year, apply for UQ's Academic Scholarship Program.

Up to 150 scholarships, ranging in value from \$6000 to \$60,000, are offered each year to students with outstanding academic achievements, or a combination of academic achievements, leadership and/ or community service achievements.

# **ARE YOU AN** INTERNATIONAL STUDENT?

While a lot of information in this guide is relevant to you, certain key information may be different for international students.

#### You are an international student if you are:

- not a citizen of Australia or New Zealand, or
- · not an Australian permanent resident, or
- · a temporary resident (visa status) of Australia.

#### **Eligibility for UQ study**

For admission into undergraduate programs at UQ, you must have:

- completed secondary studies equivalent to Queensland Year 12 with a score comparable to the Queensland rank specified for your program
- satisfied individual program requirements (e.g. specific subject prerequisites, auditions or interviews)
- · satisfied English language requirements.

If you do not meet these criteria, you might consider taking the Foundation Year bridging course offered by International Education Services (IES) or English language training offered by the Institute of Continuing and TESOL Education (ICTE-UQ).

#### **Tuition fees**

As an international student, you will pay tuition fees, a Student Services and Amenities Fee, and potentially other administrative fees. UQ has program-based tuition fees for coursework award programs, meaning that all courses within a program are charged at the same tuition fee rate per unit for a given academic year. Some programs also have additional costs.

#### Other expenses

International students applying to study in Australia must have a student visa or an alternative visa that enables them to study full-time on campus. Please consider expenses such as visa and medical (predeparture) fees, tuition fees, general living expenses, return airfares, and Overseas Student Health Cover (OSHC) when you plan your budget.

#### **Fees and costs**

#### Course fees and student contributions

Most undergraduate places at UQ are funded partly by the Australian Government (Commonwealth support) and partly by you (student contribution).

If you are an Australian or New Zealand citizen, or an Australian permanent resident and have a Commonwealth-supported place, you qualify for Commonwealth support.

International students pay full tuition fees. If you have a Commonwealth-supported place, your student contribution amount depends on the fee band level of the courses you choose (see table above right). Fees are charged according to the courses you choose, not the program you are enrolled in, so it is not possible to publish a fixed fee for a program. Because most students can choose different electives during their program, costs will vary.

However, indicative annual fees are listed with each program on our Future Students website to help you plan your budget.

#### **Student Services and Amenities Fee**

The Student Services and Amenities Fee (SSAF) is a compulsory fee that is used to subsidise, support or fund non-academic services for students, such as support services, advocacy, study skills, career development and employability.

UQ levies the SSAF - which is capped at a maximum of \$298 for 2018 - according to whether you are an internal or external student, and full-time or part-time. The fee is indexed annually.
