#### BMath/BEcon

BMath/BEcon students complete #32 from the BEcon course list, comprising #16 of compulsory courses from Group 1 not including ECON1050 and ECON1310, and #4 from Group 2 and #6 from Group 3 and #6 of electives from Group 2 and/or 3.

### \* Incompatibles

\*ECON1050 is incompatible with EC131 or MATH1050 or MATH1051.

\*\***ECON1310** is incompatible with EC134 or EC135 or CHEE3010 or MINE3214 or STAT1201 or 2201 or MS101+(102 or 112) or 103 or 113 or 240.

**BE/BEcon and BE(Hons)/BEcon** – Students in the BE/BEcon or BE(Hons)/BEcon are exempt from ECON1050. A student required to complete STAT2201, STAT2203, CHEE2010, CHEE3010 or MINE3214 for the BE component of the program is exempt from ECON1310.

**BEcon/BSc** – ECON1310 is incompatible with STAT1201 or STAT2201.

Where students are required to take the incompatible course to ECON1050 and/or ECON1310 for the External dual component, an exemption will apply.

Students who are exempt from ECON1050 and/or ECON1310 are required to take a #2 BEcon course from group 2 or 3 of the BEcon course list in replacement of each #2 exemption.

If you completed ECON1050 + MATH1050 prior to 2013, or you completed ECON1050 + MATH1051 in 2013, please contact an Academic Administrative Officer in the BEL Faculty for advice.

Students who completed PSYC1040+PSYC2010 prior to 2012 should contact an Academic Administrative Officer in the BEL Faculty for advice regarding ECON1310.

#### \* MATH1040

You cannot take MATH1040 as part of this program.

#### Grades of 3

Only #8 at a pre-2006 grade of 3 (conceded pass) can be counted towards the dual degree (#8 across both components – NOT #8 each). From Semester 2 2004, any grade of 3 obtained in a previous program cannot be granted as credit towards any new program.
